Discussion of questions/concerns shared by Mary Ellen Roberts, next Women's Rectora for #130 from meeting held with her, Kevin Sutton and Kevin Kisbey-Green on October 22. Major concern regarding the "cut-off"date for when team members must be "qualified" so as to eligible to serve as Core Team and Table Leaders. Agreed that all "qualification" must be completed by Nov 16th SOL (Day of Reflection). After the November Day of Reflection, a new list of eligible team members will be provided to Mary Ellen for her use to begin team selection. Agreement that "Team Selection/Formation" begins with first phone call to ANY prospective team member—this includes Core Team members.

- The confusion associated with selection process for the current Women's Team is attributed to two factors—1)the lack of a Rector Briefing being given by the entire Secretariat to the current Rectora and 2) lack of written guidelines to assist a Rector with the team selection process.
